# Airbag Safety Recall Sublet Program Announcement:

An Opportunity for Installers to Increase Their Bottom Line.

The safety of the people who drive and ride in Chrysler, Dodge, Jeep<sup>®</sup> and Ram Brand vehicles is our highest priority. Despite substantial and unprecedented outreach activities, many vehicles remain unrepaired. The pace of Airbag Safety Recall completions continues to slow and is of great concern to Fiat Chrysler Automobiles.

In an effort to provide additional ways to complete recalls in an efficient manner, Chrysler, Dodge, Jeep and Ram dealers are now permitted to sublet certain Airbag Safety Recalls to independent repair facilities (IRFs) and auctions.

# FCA US Airbag Safety Recall Sublet Program

What It means to Installers:

Participating IRFs and auctions work directly with local FCA dealers to formalize an agreement to enable the repair of these critical airbag recalls. The IRF and/or auction performs the repair and is **reimbursed** for this activity directly from the dealer like any other sublet repair.

## Sublet Repair Process - How It Works:

IRFs and Auctions begin by checking the Chrysler, Dodge, Jeep, and Ram vehicles being serviced at their facility for open recalls by entering the VIN on **recalls.mopar.com** 



## **Getting Started**

- 1. Contact your local Chrysler, Dodge, Jeep and Ram dealer and **tell them you're interested** in the FCA US Airbag Recall Sublet Program.
- 2. Agree on a process for notification and parts purchase with your Dealer Partner.
- 3. Complete the Indemnification Agreement, available online at www.moparrepairconnect.com/mechanical/airbagrecallsubletprogram.
- 4. Send a copy of the completed Indemnification Agreement to Airbag\_IRF\_indemnity@fcagroup.com.

#### **Tool Requirements**

A generic scan tool is required to clear codes if present after the repair.
